

The incident occurred <u>47</u> minutes into the game and was as follows:

John Smith from Apples team received a caution in the match for dissent from the referee at the 34th minute. In the 47th minute Smith was cautioned again for dissent towards the officiating crew once the ball had left the field of play. Smith was shown a second yellow card for his dissent and then shown a red card for receiving a second yellow, at this point he collected his belongings and left the field. Play restarted with a throw-in from where it had left the field.
