The incident occurred 9 minutes into the game and was as follows:

Team Defending This Side:

John Smith, # 5 on Banana FC, was chasing after an opponent, as his opponent moved towards the boards, Smith challenged his opponent, dropping his shoulder, coming in from behind, and with speed. This contact, initiated by Smith, forced his opponent to hit the board headfirst, endangering the safety of this opponent. The contact excessive and due to the direction and speed of the hit, his opponent was not able to protect or prepare himself for the collision with the boards, further increasing the danger to his opponent.

The referee stopped play for the foul, sent Smith off for boarding, and called on medical attention for the opponent. Play was restated with a direct free kick from the point of contact.
