The incident occurred 48 minutes into the game and was as follows:

Jane Smith collided with an opponent around center field, the referee allowed play to continue as Smith went down with an injury, because their opponents moved towards the Apples net with a scoring opportunity. When the phase of play ended the referee stopped play for the injury to be addressed. At this point Smith got up and began to yell at the referee, disagreeing with the no call and continuing to dispute the referee's call. Smith had received a caution for dissent earlier in the match and was warned several times about their language and actions. As they walked by the referee Smith yelled at the referee "You fucking me ref!" The comment was public, personally directed towards the referee, and provocative. The referee then showed the red card and sent off Smith for the offensive abusive and insulting language use.

Smith continued to yell and swear at the referee, all public and directed towards the referee. This included "I cannot believe that I am being refereed by a 12-year-old, who put them in this game!" "They shouldn't be here, they cannot control the match" "You are fucking crazy!" "Are you fucking happy now referee! This is how you are going to referee?!"

Since play was stopped for Smith's injury, it was restarted with a drop ball from the point where the ball was when play was stopped.
